The employers are also mandated to conduct sensitization workshops for their employees periodically to make them source about the provisions of the Act and towards the need for upholding the dignity of women and end gender sterotypes so as to encourage more and more without to participate in economic activities. This will contribute to the realisation of gender equality and result in inclusive growth for the benefit of individuals, the family and nation as a whole,




