It also includes any act affecting the mental health and self-confidence of a fresher or any other student with or without intent to

derive a sadistic pleasure orshowingoffpower,authorityorsuperioritybyastudentoveranyfresheroranyotherstudent, and all such incidents.

Mandatory reading material for all students of Sanskrithi School of Business:

The legal definition of ragging is as follows:

'Ragging' means the doing of any act which causes, or is likely to cause any physical, psychological or physiological harm of apprehension or shame or embarrassment to a student, and includes

- Teasing or abusing of playing Practical joke on, or causing hurt to any
- · Asking any student to do any act, or perform anything, which he/she would not, in the ordinary course, be willing to do or perform.

Ragging is different from other crimes because the motive is solely to get perverse pleasure. Ragging is also different from other crimes as it is actively promoted by certain sections of the society

Following types of abuses and activities will be termed as ragging:

Physical abuse, for example, forcing to eat, drink or smoke, forcing to dressor e chotologs

Observation and Directives of the Supreme Court:

The Supreme Court of India has observed that enrolment in academic pursuits or a campus life should not implusize any adulticitizen from the penal provisions of the laws of the land. According to the directions of the Supreme Court if any instance of ragging is brought to the notice of the administration or the faculty, it is legal binding on the institute to report the matter to the Local Police.
